- It is understood that I am to make payment of interest semi-annually during the period that I am attending a college, university, or trade school at the rate of 1 percent per annum. Upon completion or discontinuance of my attending such college, university, or trade school, the obligation shall become due and shall bear interest, if not paid, at the rate of interest charged on commercial loans by the Community Foundation of the Great River Bend, Inc.
- If, at the expiration of 7 years from the date of my first loan from the Community Foundation of the Great River Bend, I am still attending a college, university or trade school the obligation shall nevertheless immediately become due and shall bear interest, if not paid in, at the rate charged on commercial loans by Wells Fargo Bank, Iowa, N.A. unless other terms are agreed to by the Community Foundation of the Great River Bend, Inc.
- To execute renewal note or notes upon request.
- To advise the Community Foundation of the Great River Bend, Inc., promptly as to my school address and any change in my home address.
- To furnish the Community Foundation of the Great River Bend, Inc. my scholastic grades at the end of each semester, or not less than twice a year.
- To reply promptly to correspondence with relation to said loan and to furnish additional information upon request to either the Rotary Club of Davenport or the Community Foundation of the Great River Bend, Inc., or its successors in trust.
- To advise The Community Foundation of the Great River Bend, Inc. promptly upon the completion of my college or vocational school course or upon its discontinuance. To furnish collateral security on the said note upon request of the Community Foundation of the Great River Bend, Inc.
- To make payment of principal or arrange satisfactory terms of payment with the Community Foundation of the Great River Bend, Inc.
- In the event of my failure to meet the above requirements, I understand demand will be made for the payment of the loan.
